

## Old School RuneScape Deadman: Reborn 2021

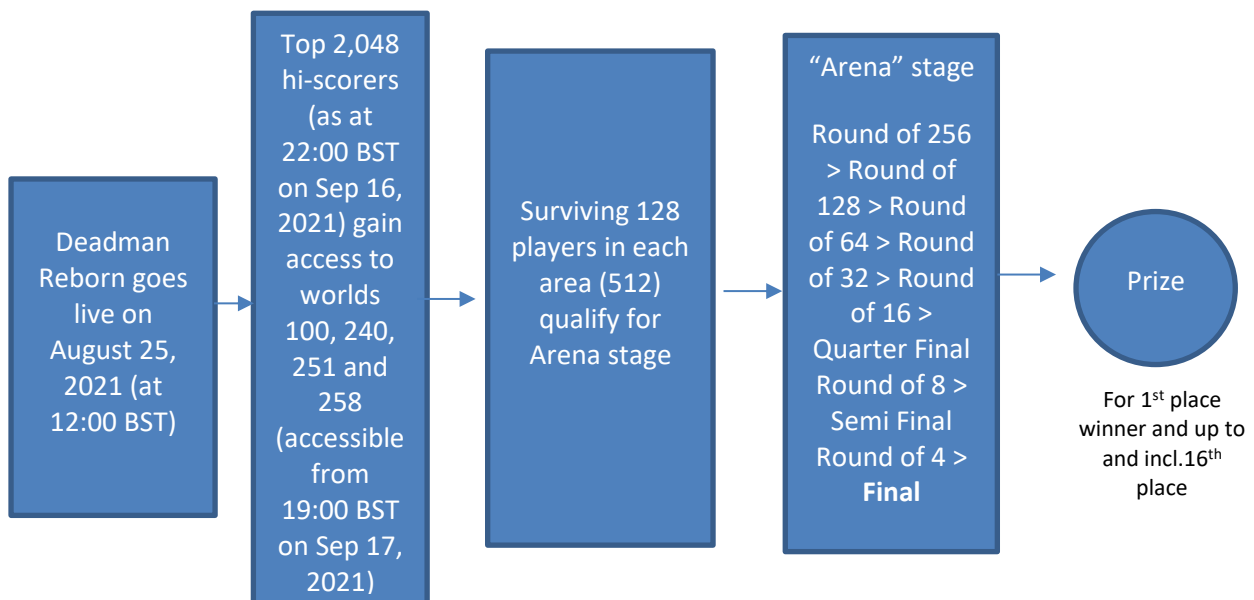
### Terms and Conditions

The Old School RuneScape Deadman Reborn event (the “**Competition**”) is a three week-long event taking place from 25 August 2021 to 17 September 2021 in the regions set out in section 5 of these terms and conditions (“**Ts & Cs**”). The Competition takes place exclusively within Old School RuneScape, the MMORPG made available by Jagex Limited on personal computer and mobile devices (“**OSRS**”).

The Deadman Reborn Worlds (as defined below) will go live on Wednesday 25 August 2021 at 12:00 British Summer Time (“**BST**”) (please check your local times). On Thursday 16 September, 2021 at 22:00 BST, the top 2,048 players (as per the High Score List) will qualify to access game worlds 100, 240, 251 and 258 for the Final and the chance to win the prizes set out in section 6 of these Ts & Cs. These Ts & Cs set out everything you need to know regarding entry to and participation in the Competition.

#### 1 THE COMPETITION

- 1.1 This Competition is being organised and promoted by Jagex Limited of 220 Cambridge Science Park, Cambridge, England, CB4 0WA (“**Jagex**”, “**us**” or “**we**”). These Ts & Cs govern the legal relationship between Jagex and you (referred to in these terms and conditions as “**you**”, “**yours**” or “**player**”) in relation to the Competition.
- 1.2 Please read these Ts & Cs carefully, and in particular paragraphs 7.2, 7.3, 7.4 and 7.5 regarding how we will handle your personal data in relation to the Competition.
- 1.3 The structure of the Competition is as follows:



- 1.4 All information detailed on any Jagex websites (including but not limited to [www.jagex.com](http://www.jagex.com), [www.runescape.com](http://www.runescape.com) and [www.oldschool.runescape.com](http://www.oldschool.runescape.com) hereafter referred to as “**Jagex Websites**”), OSRS, digital platforms (including Twitch if relevant), other games or apps or published in any of our newsletters in relation to the entry requirements for this Competition form part of these Ts & Cs. In the event of any discrepancy or conflict between that information and these Ts & Cs, these Ts & Cs will prevail.

## 2 HOW TO ENTER

2.1 The Competition will run from 25 August to 17 September 2021 as follows:

2.2 No purchase is necessary to participate in the Competition (although participation in the Competition will require you to have membership to OSRS and have internet connectivity).

2.3 By participating in the Competition at any time, you are agreeing to be bound by these Ts & Cs for the duration of the Competition.

## 3 HOW TO PARTICIPATE

3.1 A detailed guide setting out the mechanics of the Competition (including any issues reported during the Competition and relevant hotfixes) can be found [here](#) (the “**Competition Mechanics**”).

3.2 The overview of the Competition is as follows:

3.2.1 The Deadman: Reborn game worlds 101-112, 123, 138-141, 157-162, 202-204, 268-270, 278 and 281 (the “**Deadman Reborn Worlds**”) will go live globally on Wednesday 25 August 2021 at 12:00 BST. To enter, at this time, you must log in with your OSRS account and access Deadman Reborn Worlds.

3.2.2 On 16 September 2021 at 22:00 BST, all Deadman Reborn Worlds will go offline. You have until this time to reach the top 2,048 on the high score list, which is available [here](#) (the “**High Score List**”). The top 2,048 players on the

High Score List will then be flagged to access game worlds 100, 240, 251 and 258 and participate in the final stages, also known as the “1v1” stage.

- 3.2.3 The flagged players will be able to access the game worlds 100, 240, 251 and 258 from 19:00 BST on Friday 17 September 2021.
- 3.2.4 The 1v1 stage of the Competition will begin at 20:00 BST on Friday 17 September 2021. Players will be teleported to an arena set-up. Within this arena set-up players will be paired with another player to fight in a series of 1v1 fights until a single player remains (Round of 512 > Round of 256 > Round of 128 > Round of 64 > Round of 32 > Round of 16 > Quarter Final Round of 8 > Semi Final Round of 4 > “**Final**”). Prizes will be awarded to players who reach the quarter finals onwards, as set out in paragraph 6.
- 3.2.5 The final stage of the Competition will be livestreamed by Jagex on Twitch.
- 3.2.6 The winner will be decided after all matches have been played out. Jagex will then complete several anti-cheat checks to ensure validity of the winner(s). If any player has been found to be cheating, they will be disqualified from the Competition and banned from competitive play in OSRS and all other Jagex games indefinitely.

#### 4 GAME RULES

- 4.1 Other than as varied by these Ts & Cs, the [Rules of RuneScape](#) will apply to players’ participation in this Competition.
- 4.2 You must comply with any rules set out within the Competition Mechanics.
- 4.3 Engaging in any of the following acts will render any player automatically disqualified and a minimum ban from competitive play for 6 months:
  - 4.3.1 ‘**Boxing**’: Entering combat with a player who is in your clan or is a friend while in a player versus player zone to avoid being KO’d by an opposing team or player;
  - 4.3.2 ‘**Muling**’: Utilising any number of secondary accounts during the Competition which remain, in the Deadman safe zone retaining your first account’s valuable items whilst your main account engages in the Competition.
- 4.4 During the 1v1 stage, should a player experience connectivity issues and log out before a fight begins, that player has until the fight begins to log back in. If the player experiencing the connectivity issues is unable to log back in before the fight begins, they will be deemed to have been automatically disqualified.
- 4.5 During the 1v1 stage, should credible evidence emerge to suggest that an account is maliciously targeting other players, we will take action against them.
- 4.6 We will not, at any point or under any circumstances, restart the Final.
- 4.7 We will endeavour to announce the results of the Final on the night of the event, but should more investigation be required, the results will be announced separately.

## 5 ELIGIBILITY

5.1 The Competition is open to any players who are legal residents in: (a) all states within Australia, and/or New Zealand, as well as throughout Hong Kong and/or Singapore; (b) all countries within Europe except Northern Ireland and Italy; (c) the following states within the USA: Alabama; Alaska; Arizona; Arkansas; California; Colorado; Connecticut; Delaware; Florida; Georgia; Hawaii; Idaho; Indiana; Illinois; Iowa; Kansas; Kentucky; Louisiana; Maine; Maryland; Massachusetts; Michigan; Mississippi; Missouri; Minnesota; Montana; New Hampshire; New Jersey; New Mexico; New York; North Carolina; Oregon; Oklahoma; Pennsylvania; Nebraska; Nevada; North Dakota; Ohio; Rhode Island; South Carolina; South Dakota; Tennessee; Texas; Utah; Vermont; Virginia; West Virginia; Washington; Wisconsin; Wyoming; (d) the following provinces within Canada: Alberta, British Columbia; Manitoba; Ontario; Newfoundland and Labrador; New Brunswick; Northwest Territories; Nova Scotia; Nunavut; Saskatchewan; Yukon and Prince Edward Island; and (e) the following countries in Latin America: Argentina, Chile, Paraguay, Peru, Uruguay, Mexico, Colombia, Brazil (these regions together the “**Competition Jurisdiction**”) aged 18 years or older or the age of majority in their country of residence at the time of registration, except:

5.1.1 employees of Jagex or its holding or subsidiary companies or other affiliates;

5.1.2 employees of agents or suppliers of Jagex or its holding or subsidiary companies or other affiliates, who are professionally connected with the Competition or its administration; or

5.1.3 members of the immediate families or households of paragraphs 5.1.1 and 5.1.2 above.

5.2 Participation in the Competition requires an OSRS account in good standing.

5.3 If you are based outside of the Competition Jurisdiction, or your jurisdiction has legal or regulatory rules that invalidate these terms or make Jagex’s performance of them impossible, you will be deemed to have been automatically disqualified from the Competition.

5.4 By participating in the Competition, you confirm that you are eligible to participate and to claim any prize you may win. Jagex may require you to provide proof that you are eligible to participate in the Competition and reserves the right to disqualify any non-eligible player from the Competition.

5.5 Jagex reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the Competition.

## 6 THE PRIZE

6.1 The prizes are as follows:

3 <sup>rd</sup> and 4 <sup>th</sup> Place (unsuccessful semi-finalists):	\$1,000 USD
5 <sup>th</sup> - 16 <sup>th</sup> Place (unsuccessful quarter finalists):	1 Year OSRS Membership

6.2 Prizes are subject to availability. Jagex reserves the right to replace any prize with an alternative prize of equal or higher value if circumstances beyond Jagex's control make it necessary to do so.

6.3 The prize is not negotiable or transferable. Any taxes and any duties payable on the prizes are the winners' sole responsibility.

## **7 WINNERS**

7.1 The decision of Jagex (including where Jagex is required to step-in to decide the outcome of any match in the event of a dispute), is final and no correspondence or discussion will be entered into.

7.2 Jagex will require further personal details of any winner in order to distribute their prize (such as real name and/or address), Jagex will contact winners by means of an inbox message and collect any additional personal information needed at that point

7.3 Jagex must either publish or make available information that indicates that a valid award took place. To comply with this obligation Jagex will publish the surname and county of major prize winners on the Jagex Website following the conclusion of the Final (the "**Announcement Date**").

In such circumstances, Jagex must still provide the information and winning entry to the Advertising Standards Authority on request. 7.6 Jagex will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available or has not provided information/accurate information in order to facilitate the award of the prize within 30 days of the Announcement Date, Jagex reserves the right to offer the prize to the next eligible winner.

7.7 Jagex may also require proof of eligibility, such as proof of age, when distributing prizes to winners. Jagex does not accept any responsibility if you are not able to take up the prize.

## **8 LIMITATION OF LIABILITY**

8.1 Insofar as is permitted by law, Jagex, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of Jagex, its agents or distributors or that of their employees. Your statutory rights are not affected.

8.2 Additionally, each winner is solely responsible for all applicable local taxes, including taxes imposed on its income.

## **9 DATA PROTECTION AND PUBLICITY**

- 9.1 Jagex will only process your personal information as set out in its privacy policy. See also paragraphs 7.3 and 7.5, with regard to the announcement of winners.

## **10 GENERAL**

- 10.1 If there is any reason to believe that there has been a breach of these Ts & Cs, Jagex may, at its sole discretion, reserve the right to exclude you from participating in the Competition.
- 10.2 Jagex reserves the right to hold void, suspend, cancel, or amend the Competition where it becomes necessary to do so:
- 10.2.1 for reasons outside of its control (including, without limitation, if any law or regulation is inconsistent with these terms or where any law or regulation makes Jagex's performance of these terms impossible, unlawful, illegal, or unethical); or
  - 10.2.2 where any other unforeseen or unexpected event that cannot be reasonably anticipated or controlled, affects the fairness and/or integrity of the Competition (including, without limitation, in the case of anticipated, suspected or actual fraud, cheating, any computer virus, bug, or any catastrophic event).
- 10.3 These Ts & Cs shall be governed by the law of England and Wales, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
