

JAGEX COMPETITION TERMS AND CONDITIONS

Last updated: 25th May 2022

THE COMPETITION

- 1.1 The promoter and organiser of this competition is **Jagex Limited**, a company incorporated in England and Wales with registration number 03982706 whose registered office is at 220 Cambridge Science Park, Milton Road, Cambridge, CB4 0WA ("**Jagex**", "**us**" or "**we**"). These terms and conditions govern the legal relationship between Jagex and you (referred to in these terms and conditions as "**you**", "**yours**" or "**Entrant**") in relation to the competition.
- 1.2 Please read these terms and conditions carefully, and in particular clause 6.2, 6.4 and 6.5 regarding how we will handle your personal data in relation to the competition.
- 1.3 The title of the competition is "Group Boss Bash".
- 1.4 All information detailed on any of Jagex websites digital platforms, games or apps (collectively "**Jagex Sites**") in relation to the entry requirements for this competition form part of these terms. In the event of any discrepancy or conflict between that information and these competition terms, the specific competition terms and conditions will prevail.

HOW TO ENTER

- 2.1 The competition will run from 11:30am UTC on 26th May 2022 (the "**Opening Date**") to 23:59pm UTC on 9th June 2022 (the "**Closing Date**") inclusive.
- 2.2 All competition entries must be received by Jagex by no later than 23:59pm UTC 9th June 2022 on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
- 2.3 **NO PURCHASE IS NECESSARY TO ENTER THE COMPETITION.**
- 2.4 To enter the competition, Entrants must register their group (which can be between 2 and 5 players in size) and complete the specific Old School RuneScape game content. You will then receive a virtual prize draw ticket. Upon receipt of your virtual ticket, you will be automatically entered into the prize draw where the winning virtual tickets will be drawn at random.
- 2.5 Jagex will not accept:
 - 2.5.1 responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
 - 2.5.2 proof of posting or transmission as proof of receipt of entry to the competition.
- 2.6 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

PRIZE DRAW PROCESS

- 3.1 Within 10 days following the Closing Date (unless specified otherwise by Jagex in writing), competition winners will be randomly selected from the Prize Draw Pool by way of a random number generator.
- 3.2 Details verifying the randomised selection from the Prize Draw Pool will be provided in accordance with the winner details in paragraph 6.

ELIGIBILITY

- 4.1 The competition is open to any players who are legal residents in: (a) all states within New Zealand, as well as throughout Hong Kong and/or Singapore; (b) all countries within Europe except Northern Ireland and Italy; (c) the following: states within the USA: Alabama; Alaska; Arizona; Arkansas; California; Colorado; Connecticut; Delaware; Florida; Georgia; Hawaii; Idaho; Indiana; Illinois; Iowa; Kansas; Kentucky; Louisiana; Maine; Maryland; Massachusetts; Michigan; Mississippi; Missouri; Minnesota; Montana; New Hampshire; New Jersey; New Mexico; New York; North Carolina; Oregon; Oklahoma; Pennsylvania; Nebraska; Nevada; North Dakota; Ohio; Rhode Island; South Carolina; South Dakota; Tennessee; Texas; Utah; Vermont; Virginia; West Virginia; Washington; Wisconsin; Wyoming; (d) the following provinces within Canada: Alberta, British Columbia; Manitoba; Ontario; Newfoundland and Labrador; New Brunswick; Northwest Territories; Nova Scotia; Nunavut; Saskatchewan; Yukon and Prince Edward Island; and (e) the following countries in Latin America: Argentina, Chile, Paraguay, Peru, Uruguay, Mexico, Colombia, Brazil (these regions together the “**Competition Jurisdiction**”) aged 18 years or older or the age of majority in their country of residence at the time of registration, except:
 - 4.1.1 employees of Jagex or its holding or subsidiary companies;
 - 4.1.2 employees of agents or suppliers of Jagex or its holding or subsidiary companies, who are professionally connected with the competition or its administration; or;
 - 4.1.3 members of the immediate families or households of paragraphs 4.1.1 and 4.1.2 above.
- 4.2 If you are based outside of the Competition Jurisdiction, or your jurisdiction has legal or regulatory rules that invalidate these terms or make Jagex’s performance of them impossible, Jagex will not accept your competition entry and you will be deemed to have been automatically disqualified from it.
- 4.3 In entering the competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. Jagex may require you to provide proof that you are eligible to enter the competition and reserves the right to disqualify any non-eligible entrant to does not eligible to enter the competition.
- 4.4 Jagex will not accept competition entries that are:
 - 4.4.1 automatically generated by computer;
 - 4.4.2 completed by third parties or in bulk;
 - 4.4.3 illegible, have been altered, reconstructed, forged, or tampered with;

- 4.4.4 photocopies and not originals; or
- 4.4.5 incomplete.
- 4.5 There is a limit of one entry to the competition per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- 4.6 Jagex reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.
- 4.7 Competition entries cannot be returned.

THE PRIZE

- 5.1 The prizes to be won – 1 prize (for all group members) consisting of a free life membership of the Old School RuneScape game and 9 prizes (for all group members) consisting of a 12-month free membership of the Old School RuneScape game. The approximate retail value of each prize will be \$2800 and \$80 respectively, and total value of the prizes available will be \$18,000.
- 5.2 Prizes are subject to availability. Jagex reserves the right at its discretion to substitute the prize with a cash alternative to the value of \$18,000, or to substitute the prize with a prize of equal or greater value. Jagex accepts no responsibility for any costs associated with the prize and not specifically included in the prize.
- 5.3 The prize is not negotiable or transferable.

WINNERS

- 6.1 The decision of Jagex is final and no correspondence or discussion will be entered into.
- 6.2 Jagex must either publish or make available information that indicates that a valid award took place. To comply with this obligation Jagex will publish the username and county of major prize winners on 9th June 2022 on oldschoolorunescape.com. ("**Announcement Date**").
- 6.3 Jagex will contact the winner personally as soon as practicable after the Announcement Date, via their game account inbox. Jagex will not amend any contact information once the competition entry form has been submitted.

CLAIMING THE PRIZE

- 7.1 The prize may not be claimed by a third party on your behalf.
- 7.2 Jagex will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available or has not claimed their prize within 7 of days of the Announcement Date, Jagex reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.

7.3 Jagex does not accept any responsibility if you are not able to take up the prize.

LIMITATION OF LIABILITY

8.1 Insofar as is permitted by law, Jagex, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of Jagex, its agents or distributors or that of their employees. Your statutory rights are not affected.

OWNERSHIP OF COMPETITION ENTRIES AND INTELLECTUAL PROPERTY RIGHTS

9.1 All competition entries and any accompanying material submitted to Jagex will become the property of Jagex on receipt and will not be returned.

11.2 Jagex reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so, including if any law or regulation is inconsistent with these terms or where any law or regulation makes Jagex' performance of these terms impossible, unlawful, illegal or unethical.

11.3 These terms and conditions shall be governed by the laws of England and Wales and the parties submit to the exclusive jurisdiction of the courts of England and Wales.
