

# **COMPETITION TERMS AND CONDITIONS**

### **DEADMAN APOCALYPSE**

The Old School RuneScape Deadman Apocalypse event (the "Competition") is a three week-long event taking place from 25 August 2023 to 16 September 2023 in the regions set out in section 6 of these terms and conditions. The Competition takes place exclusively within Old School RuneScape, the MMORPG made available by Jagex Limited on personal computer and mobile devices ("OSRS").

The Deadman Apocalypse Worlds (as defined below) will go live on 25 August 2023 at 17:00 BST (please check your local times). On 16 September 2023 at 18:00 BST, the finale will start and players will compete to be the last player standing on one of the 5 worlds during the "Monster Breaches" and win a prize. These terms and conditions set out everything you need to know regarding entry to and participation in the Competition.

Please see the high score list <u>here</u> to keep track of the scores once the competition begins.

### THE COMPETITION

- 1.1 The promoter and organiser of this Competition is Jagex Limited of 220 Cambridge Science Park, Cambridge, England, CB4 0WA ("Jagex", "us"," or "we"). These terms and conditions govern the legal relationship between Jagex and you (referred to in these terms and conditions as "you", or "entrant") in relation to the Competition.
- 1.2 Please read these terms and conditions carefully, and in particular clauses 8.2, 11.1 and 11.2 regarding how we will handle your personal data in relation to the Competition.
- 1.3 All information detailed on any of Jagex websites (including but not limited to jagex.com, www.runescape.com and www.oldschool.runescape.com, hereafter referred to as "Jagex Websites"), digital platforms, games or apps or published in any of our newsletters in relation to the entry requirements for this Competition form part of these terms. In the event of any discrepancy or conflict between that information and these Competition terms, the specific Competition terms and conditions will prevail.
- 1.4 Twitter, Facebook, Discord and Reddit (or any other social media site) do not endorse or sponsor any competitions hosted by Jagex and we are not affiliated with Twitter, Facebook, Discord and Reddit or any other social media site in any way.

### **HOW TO ENTER**

2.1 The Competition will run from 25 August 2023 to 16 September 2023 as follows:

- 2.2 No purchase is necessary to participate in the Competition (although participation in the Competition will require you to have membership to OSRS and have internet connectivity).
- 2.3 By participating in the Competition at any time, you are agreeing to be bound by these terms and conditions for the duration of the Competition.

### **HOW TO PARTICIPATE**

- 3.1 A detailed guide setting out the mechanics of the Competition (including any issues reported during the Competition and relevant hotfixes can be found <a href="here">here</a> (the "Competition Mechanics").
- 3.2 The overview of the Competition is as follows:
  - 3.2.1 The Deadman: Apocalypse game worlds 385, 400-412, 438-440, 442, 458, 460-462, 472, 473, 536, 538, 541, 550, 551, 574 and 590-592 (the "Deadman Apocalypse Worlds") will go live globally on 25 August 2023 at 17:00 BST. To enter, at this time, you must log in with your OSRS account and access Deadman Apocalypse Worlds.
  - 3.2.2 On 15 September 2023 at 12:00 (noon) BST, all Deadman Apocalypse Worlds will go offline. All players who have (A) adhered to clause 3.2.1 and (B) left "Tutorial Island" before 12:00 (noon) BST on 15 September 2023 will be able to access the grand finale. Players will no longer be able to obtain points after 15 September 2023 at 12:00 (noon) BST.
  - 3.2.3 The finale worlds 400, 405, 407, 409 and 412 will open on 16 September 2023 at 17:00 BST. Eligible entrants will have one hour to log in to the finale worlds before the finale begins at 18:00 BST on 16 September 2023. The finale will finish upon the death of the final player. Prizes will be awarded as set out in clause 5 of these terms and conditions.
  - 3.2.4 The final stage of the Competition will be livestreamed by Jagex on Twitch.
  - 3.2.5 The winner will be decided after the finale has finished. Jagex will then complete several anticheat checks to ensure validity of the winner(s). If any player has been found to be cheating, they will be disqualified from the Competition and banned from competitive play in OSRS and all other Jagex games indefinitely.
- 3.3 There is a limit of one entry to the Competition per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- 3.4 By submitting your entry, you confirm that you have read and understood these terms and conditions and agree to be bound by them.

# **GAME RULES**

- 4.1 Other than as varied by these terms and conditions, the <u>Rules of RuneScape</u> will apply to players' participation in this Competition.
- 4.2 You must comply with any rules set out within the Competition Mechanics.
- 4.3 Engaging in any of the following acts will render any player automatically disqualified and a minimum ban from competitive play for 6 months:

- 4.3.1 'Boxing': Entering combat with a player who is in your clan or is a friend while in a player versus player zone to avoid being KO'd by an opposing team or player;
- 4.3.2 'Muling': Utilising any number of secondary accounts during the Competition which remain in the Deadman safe zone retaining your first account's valuable items whilst your main account engages in the Competition.
- 4.4 We will only consider restarting the competition (or any stage of it) in exceptional circumstances, and our decision in this regard will be final and at our sole discretion.
- 4.5 We will endeavour to announce the results of the Final on the night of the event, but should more investigation be required, the results will be announced separately.

### **THE PRIZE**

- 5.1 The prizes are as follows:
  - 5.1.1 \$1,000 USD to the last player alive on each of the 5 finale worlds.
  - 5.1.2 \$1,000 USD to 20 players who achieve at minimum the adamant tier trophy, broken down as follows:
    - 5.1.2.1 5 winners from top page for points (rank 1-25).
    - 5.1.2.2 7 winners from "dragon" rank (top 1% of players on the highscores).
    - 5.1.2.3 5 winners from "rune" rank (top 5% of players on the highscores).
    - 5.1.2.4 3 winners from "adamant" rank (top 20% of players on the highscores).
- 5.2 The winner is responsible for any costs or expenses involved in claiming or using the prize other than those that are expressly stated above as being included as part of the prize.
- 5.3 The prize is not negotiable or transferable.
- 5.4 The prize is for the named winners only and cannot be given or transferred to any other person.
- 5.5 Prizes are subject to availability. Jagex reserves the right to replace any prize with an alternative prize of equal or higher value if circumstances beyond Jagex's control make it necessary to do so.

### **ELIGIBILITY**

- 6.1 To enter this Competition, you must be a legal resident in: (a) all states within Australia, and/or New Zealand, as well as throughout Hong Kong and/or Singapore; (b) all countries within Europe except Northern Ireland and Italy; (c) the following: states within the USA: Alabama; Alaska; Arizona; Arkansas; California; Colorado; Connecticut; Delaware; Florida; Georgia; Hawaii; Idaho; Indiana; Illinois; Iowa; Kansas; Kentucky; Louisiana; Maine; Maryland; Massachusetts; Michigan; Mississippi; Missouri; Minnesota; Montana; New Hampshire; New Jersey; New Mexico; New York; North Carolina; Oregon; Oklahoma; Pennsylvania; Nebraska; Nevada; North Dakota; Ohio; Rhode Island; South Carolina; South Dakota; Tennessee; Texas; Utah; Vermont; Virginia; West Virginia; Washington; Wisconsin; Wyoming; (d) the following provinces within Canada: Alberta, British Columbia; Manitoba; Ontario; Newfoundland and Labrador; New Brunswick; Northwest Territories; Nova Scotia; Nunavut; Saskatchewan; Yukon and Prince Edward Island; and (e) the following countries in Latin America: Argentina, Chile, Paraguay, Peru, Uruguay, Mexico, Colombia, Brazil (these regions together the "Competition Jurisdiction") and be aged 18 years or over at the time of entry.
- 6.2 The following persons are not eligible to enter:



- 6.2.1 our employees or workers, or the employees or workers of any our holding or subsidiary companies;
- 6.2.2 employees or workers of any organisation involved in the operation or administration of this Competition including prize suppliers and advertising agencies; or
- 6.2.3 members of the immediate families or households of clauses 6.2.1 and 6.2.2.
- 6.3 Participation in the Competition requires an OSRS account in good standing.
- 6.4 If you are based outside of the Competition Jurisdiction, or your jurisdiction has legal or regulatory rules that invalidate these terms or make Jagex's performance of them impossible, you will be deemed to have been automatically disqualified from the Competition.
- 6.5 In entering the Competition, you confirm that you are eligible to do so and eligible to claim any prize you may win.
- 6.6 We may ask for proof of age, residence, or eligibility. Delay or failure to provide the evidence to our reasonable satisfaction may result in an entry being void or a prize being forfeited.
- 6.7 Our decision as to whether an entrant (or their entry) is eligible for this Competition is final and we are not obliged to provide any reasons for disqualification.
- 6.8 There is a limit of one entry to the Competition per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- 6.9 Jagex reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize Competition.

## **SELECTION OF WINNER**

- 7.1 Please see clause 5.1 for details of how winners will be selected. The winners referred to in clause 5.1.2 will be selected using Google's random number generator.
- 7.2 The decision of Jagex (including where Jagex is required to step-in to decide the outcome of any match in the event of a dispute), is final and no correspondence or discussion will be entered into.
- 7.3 Jagex will require further personal details of any winner in order to distribute their prize (such as real name and/or address), Jagex will contact winners by means of an inbox message and collect any additional personal information needed at that point.

## **CONTACTING THE WINNER**

- 8.1 We will notify the winner as soon as practicable after the Announcement Date using the contact details provided in the entry. Jagex will not amend any contact information once the Competition entry form has been submitted.
- 8.2 Jagex must either publish or make available information that indicates that a valid award took place. To comply with this obligation Jagex will publish the username of major prize winners on a Jagex Website on 22 September 2023 ("Announcement Date").
- 8.3 Reasonable efforts will be made to make contact over a period of 2 weeks of the Announcement Date. If it has not been possible to contact the winner in that time, the prize will be forfeited and awarded to the next eligible entrant.
- 8.4 Once contacted, the entrant must comply with any reasonable requests made by us (for instance requests for bank account details or other relevant details to allow us to transfer the prize).

### **CLAIMING THE PRIZE**

- 9.1 The prize may not be claimed by a third party on your behalf.
- 9.2 We do not accept any responsibility if you are not able to take up the prize.
- 9.3 We are not liable for any damage or loss to a prize caused by a third party. If a prize is damaged or fails to be delivered, we have no obligation to provide a replacement prize.

### **LIMITATION OF LIABILITY**

10.1 Insofar as is permitted by law, Jagex, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of Jagex, its agents or distributors or that of their employees. Your statutory rights are not affected.

### **DATA PROTECTION AND PUBLICITY**

- 11.1 We will use your personal information only in accordance with these terms and conditions and our privacy policy. See also 8.2, with regard to the announcement of winners.
- 11.2 Entrants who do not want their username included on the list of winners referred to in clause 7.2 being published or made available, you must notify us within a reasonable period of time before the Closing Date of this Competition by emailing competitions@jagex.com or writing to: Competitions Team, Jagex Limited, 220 Cambridge Science Park, Cambridge, England, CB4 0WA. In such circumstances, Jagex must still provide the information and winning entry to the Advertising Standards Authority on request.
