

### PROMOTION TERMS AND CONDITIONS

#### **OSRS Annual Survey 2023**

#### 1 THE PROMOTION

#### 2 HOW TO ENTER

- 2.1 In order to enter the promotion, you must complete the official Jagex "OSRS Annual Survey 2023" that can be found on the Jagex Websites and on official RuneScape social accounts and providing the required information.

- 4.2 The following persons are not eligible to enter:

- 5.2 All valid entries received by Jagex before the Closing Date will be eligible for the prize draw process ("Prize Draw Pool").

- 5.4 Within 21 days following the Closing Date (unless specified by Jagex in writing), the winner of this promotion will be randomly selected from the Prize Draw Pool by way of a random algorithm operated through Microsoft Excel.
